Again thank you for helping us for the past several months. It's much appreciated."



On behalf of all of our truly grateful clients, thank you for your generosity.

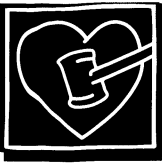
